RM Billing

Charges for residential waste from the RM area (with the exception of fees for untarped loads will be logged and billed directly to the RM on a monthly basis.

Untarped loads will be paid directly to the Landfill by the hauler.

Other Billing

Charges for all users other than RM residential waste will be collected directly from the user. Large users, such as commercial haulers, septic haulers and vegetable farmers may be billed on a monthly basis.

Default in Payment

Where charges are not paid from users located within the City or RM, the applicable municipality will be advised and charges may be turned over to the municipality and thereafter added to taxes on the user's properties or tipping services withheld in order to obtain collection.

Penalty

A penalty of 1.25% per month is applied on outstanding accounts commencing the month following the month in which the invoice was issued.
